Paris City Commission 525 High Street Paris, KY 40361 Meeting Minutes November 12, 2019

The Paris City Commission met in regular session in the City Commission Chambers at 9:00 a.m. on Tuesday, November 12, 2019.

Mayor, Johnny Plummer called the meeting to order and the Pledge of Allegiance was recited.

City Clerk, Stephanie Settles conducted roll call.

Present: Mayor, John A. Plummer; Commissioner, Matt Perraut; Commissioner, Wallis Brooks; Commissioner, Stan Galbraith; Commissioner, Anna Allen-Edwards arrived at 9:06 a.m.

Others in Attendance City Manager, Daron Jordan; Attorney, Bryan Beauman.

Upon determining a quorum was present for the transaction of business, City Manager Daron Jordan, proceeded to conduct the meeting.

Approve Minutes

Motion by Mayor Plummer, seconded by Galbraith, approving the minutes of October 22, 2019 regular meeting. Motion carried by roll call vote of 4-0 with Galbraith, Perraut, and Plummer voting Aye. Brooks Abstained as he was not present at the meeting.

Old Business

Second reading of an Ordinance related to False Alarms was read by Bryan Beauman. Motion by Perraut, Seconded by Galbraith, approving Ordinance 2019-16. Motion carried by roll call vote of 4-0 with Galbraith, Brooks, Perraut, and Plummer voting Aye.

AN ORDINANCE RELATING TO FALSE ALARMS

WHEREAS, the number of false alarms within the City requires an increased number of calls upon the City's police and other city services;

NOW THEREFORE BE IT ORDAINED BY THE CITY OF PARIS CITY COMMISSION THAT THE FOLLOWING SECTIONS OF THE CODE OF ORDINACES BE AMENDED:

§ 54.005 FALSE ALARMS

- (A) Consent to pay fine; schedule of fines. For the purpose of defraying the costs to the Police Department for responding to false alarms, the owner, lessee, or user of any alarm system, user of any audible alarms and any user of any other kind of direct or indirect connection with the Police Central Communication Center, except persons using the two-way live voice communication by telephone, shall, as a condition to installation and continued operation of the equipment or service, execute a written consent form as may be prescribed by the city that the owner, lessee, or user shall pay the city for false alarms upon the following schedule for each false alarm originating from the owner's, lessee's, or user's premises.
 - (1) First through sixth second in twelve (12) months: warning.
 - (2) Third Seventh through twelfth in twelve (12) months: \$50.00 \$25.00 per

response.

- (3) Thirteen (13) or more in twelve (12) months: \$100.00 \$50.00 per response.
- (B) Failure to comply. Any such owner, lessee, or user who fails to execute the written consent form described in subsection (A), within ninety (90) days of the effective date of this chapter, shall disconnect their alarm system.
- (C) Revoke of consent. Any owner, lessee, or user may revoke their consent by notifying the Police Department, in writing, and disconnecting their alarm system.
 - (D) Acts of nature. The following shall not be included when computing the number of false alarms which have occurred:
 - (1) Any false alarm which was caused by a storm, lighting, fire, earthquake, or other acts of God; or
 - (2) Failure of a utility system, such as water, electric, gas, etc., which results in an alarm activation.

The foregoing ordinance shall take effect immediately upon execution and publication. The foregoing ordinance was introduced and read for the first time as the City

Commission's regular meeting of September 24, 2019. Read for the second time, adopted and approved at its regular meeting of November 12, 2019.

Commissioner Allen-Edwards joined the meeting at 9:06 a.m.

Remediation and repair of Legion Drive property will move forward with Thornberry Concrete LLC, as no progress or a resolution was made with Freedom Steel.

Discussion of the City personnel policy related to outside employment was discussed. Commission requested a list of pros and cons from the City Manager so that they can make policy change decisions.

Mike Withrow reported that the master water meters have not been installed because of water leak repairs.

Mike Withrow stated the new owner of a parcel on 17th street has agreed to work with the City of Paris to install a new storm drain on the property as part of the States South Main and High Street repaying project. The state project has posted a RFP that is due November 22, the anticipated cost of the project is between 6 and 7 million dollars with a begin date of July 2020 and a projected completion date of 10/31/2021.

Brad Oberlander discussed ClearGov financial information is updated monthly and available for anyone to access on the homepage of the City website. Information is broken down by department by line item.

Mike Withrow said only one bid was received for the repairs of Duncan Street Bridge, the award of bid will not be announced until a grant contract is received from the State.

Aaron Sparkman announced the Electric Department Bucket truck will be delivered at the end of November.

Daron Jordan informed the commission that old water meters across the community will begin replacement soon in an effort to reduce water loss. Commissioner Allen-Edwards asked that the City Manager to be proactive and send out an announcement to citizens that old water meters are being replaced.

Daron Jordan said the language for the Garrett Morgan signage was submitted to the State for review and approval. The signs will be placed on Paris Pike and at the Bypass of East Main Street.

RFP's were received for Engineering Services for the Water and Wastewater systems. The committee and superintendents are meeting to discuss and submit recommendation for approval to the commission at the December 10th meeting.

Motion by Brooks, seconded by Galbraith, approving the Mayor's recommendation to add Kevin Sutton to the Chief of Police Search Committee. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

Motion by Perraut, seconded by Mayor Plummer, to accept the gift of property located at 264 Lilleston Avenue contingent that all 2019 property tax bills have been paid in full. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks Perraut and Plummer voting Aye.

Mike Withrow stated that the Capacity Management Operations and Maintenance "CMOM" update and review is in process. Mike and Patrick Harney are reviewing the 80-page document.

Motion by Galbraith, seconded by Perraut, approving a Resolution appointing Wiley Faw to the Joint Board of Adjustments for a term ending January 1, 2023. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.
