Paris City Commission 525 High Street Paris, KY 40361 Meeting Minutes February 11, 2020

The Paris City Commission met in regular session in the City Commission Chambers at 9:00 a.m. on Tuesday, February 11, 2020.

Mayor, John Plummer called the meeting to order and the Pledge of Allegiance was recited.

City Clerk, Stephanie Settles conducted roll call.

Present: Mayor, John A. Plummer; Commissioner, Wallis Brooks; Commissioner, Stan Galbraith; Commissioner, Anna Allen-Edwards.

Absent: Commissioner Matt Perraut

Others in Attendance City Manager, Daron Jordan; Assistant City Manager, Mike Withrow; City Attorney, Bryan Beauman

Upon determining a quorum was present for the transaction of business, City Manager Daron Jordan, proceeded to conduct the meeting.

Approve Minutes

Motion by Allen-Edwards, seconded by Brooks, approving the minutes of January 28, 2019 regular meeting. Motion carried by roll call vote of 4-0 with Plummer, Brooks, Galbraith and Allen-Edwards voting Aye.

Old Business

Motion by Allen-Edwards, seconded by Galbraith, approving to finalize the proposal received from HMB Professional Engineers, Inc. for the proposed project and scope of work for a water audit study. Motion carried by roll call vote of 4-0 with Plummer, Brooks, Galbraith and Allen-Edwards voting Aye.

Motion by Brooks, seconded by Plummer, to approve Capacity Management Operations and Maintenance program "CMOM" plan and file. Motion carried by roll call vote of 4-0 with Plummer, Brooks, Galbraith and Allen-Edwards voting Aye.

Mike Withrow discussed the KYTC Main and High Street paving project. Walker has mobilized and working on the side street areas. The project completion date expected is October 31, 2021. The project is estimated to cost \$ 7.5 Million.

• Commissioner Allen-Edwards requested when information is available it needs to be shared with the public. Daron Jordan replied that KYTC will have a twitter account posting updates to the public once the project begins.

Bryan Beauman stated to lower the age requirement for the Fire and EMS departments a new ordinance needs to be adopted along with the policy and procedure manual. Erin Morton stated she would like to do a presentation and submit a new policy and procedure manual as multiple policies need updated.

• Commissioner Allen-Edwards asked Erin when the updated policy and procedure policy would be ready, Erin replied it is ready and can be on the next meeting agenda for consideration.

Aaron Sparkman reported the building on Legion Drive has about one week of construction remaining. The next phase will begin with installation of doors and heating.

Erin Morton mentioned she is awaiting responses from the Chief of Police Search Committee members. The committee will then call a meeting to further discuss their recommendation for the Chief of Police position. The committee will present a recommendation to the City Commission for consideration.

Motion by Brooks, seconded by Galbraith, to approve ordinance 2020-1 related to a zone change classification for 671 Clintonville Road. Motion carried by roll call vote of 4-0 with Plummer, Brooks, Galbraith and Allen-Edwards voting Aye.

CITY OF PARIS, KENTUCKY ORDINANCE NO. 2020-1

AN ORDINANCE RELATED TO CHANGING THE ZONING CLASSIFICATION FOR CERTAIN REAL PROPERTY OWNED BY CAPALL CONSTRUCTION, LLC LOCATED AT 671 CLINTONVILLE ROAD, PARIS, BOURBON COUNTY, KENTUCKY, WITH A ZONE MAP AMENDMENT FROM R-2 (RESIDENTIAL) AND AGRICULTURAL TO R-8 (RESIDENTIAL).

WHEREAS, the application for a zoning map amendment for property located at 671 Clintonville Road having been filed with the Paris-Bourbon County Joint Planning Commission (the "Joint Planning Commission") requesting a zoning classification change for 5.92 acres, more or less, from R-2 (residential) and Agricultural to R-8 (residential) (the "Property"); and

WHEREAS, the application and this zone change amendment was presented to the Paris-Bourbon County Joint Planning Commission (the "Joint Planning Commission") at its scheduled meeting on November 21, 2019 and with a quorum present, the Joint Planning Commission having voted to recommend approval of the zone change request of the Property; and

WHEREAS, the members of Board of Commissioners of the City of Paris, Kentucky reviewed the record of the evidence presented at the public hearing before the Joint Planning Commission,

NOW THEREFORE BE IT ENACTED AND ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF PARIS AS FOLLOWS:

Section 1: Based upon the record before the Joint Planning Commission, a zoning map amendment from residential to business for this Property is in agreement with the adopted comprehensive plan.

Section 2: Based upon the record before the Joint Planning Commission, the existing zoning classification of R-3 (residential) and Agricultural is inappropriate and the proposed zoning classification of R-8 (residential) is appropriate.

Section 3: In accordance with KRS 100.211, the zoning map amendment of the Property is approved.

Section 4 - The Property rezoned is more fully described as on the legal description attached as Exhibit A to this Ordinance.

Section 5- The Zoning Ordinance shall be amended to show a change in the zoning classification for the Property from R-3 (residential) and Agricultural to R-8 (residential).

Section 6 - The Paris-Bourbon County Joint Planning Commission is hereby directed to show the zoning classification change on the official zone map and to make reference to the number of this Ordinance.

Section 7 - If any provision of this Ordinance for any reason or to any extent, be invalid or unenforceable, the remainder of this Ordinance and the application of such provision to other persons or circumstances shall not be affected thereby, but rather shall be enforced to the greatest extent permitted by law.

Motion by Allen-Edwards, seconded by Plummer, authorizing the Mayor to sign a maintenance and calibration agreement for the water treatment plant with Hach for \$8,812.23. Motion carried by roll call vote of 4-0 with Plummer, Brooks, Galbraith and Allen-Edwards voting Aye.

Motion by Allen-Edwards, seconded by Brooks, approving the purchase of 10 Zoll AED's and accessories for a total purchase of \$15,765.00 for the placement in all city departments including City Hall. Motion carried by roll call vote of 4-0 with Plummer, Brooks, Galbraith and Allen-Edwards voting Aye.

The commission granted permission to draft an ordinance to update the city procurement policy.

Motion by Galbraith, seconded by Brooks, to hire William Sandford as a full-time laborer within the public works department, contingent upon completing the final city manager review. Motion carried by roll call vote of 4-0 with Plummer, Brooks, Galbraith and Allen-Edwards voting Aye.

Chamber of Commerce Director Lauren Biddle requested permission for street and parking lot closure for a festival in April. The commission determined more downtown merchants needed to be contacted and a special meeting would be called on Friday, February 14th to reconsider the request. Motion carried by roll call vote of 4-0 with Plummer, Brooks, Galbraith and Allen-Edwards voting Aye.

Motion by Brooks, seconded by Plummer, approving to publish an RFP for a Utility Rate Study. Motion carried by roll call vote of 4-0 with Plummer, Brooks, Galbraith and Allen-Edwards voting Aye.

Motion by Allen-Edwards, seconded by Galbraith, authorizing the Mayor to sign a State Plan of Operations between the State of Kentucky and the City of Paris Police Department for the ability to obtain excess Department of Defense personal property. Motion carried by roll call vote of 4-0 with Plummer, Brooks, Galbraith and Allen-Edwards voting Aye.

Motion by Brooks, seconded by Galbraith, approving the publishing of an RFP for a sewer inspection camera. Motion carried by roll call vote of 4-0 with Plummer, Brooks, Galbraith and Allen-Edwards voting Aye.

AN ORDINANCE RELATED TO CHANGING THE ZONING CLASSIFICATION FOR CERTAIN REAL PROPERTY OWNED BY JOHNSON FUNERAL HOME, INC. LOCATED AT 1120 MAIN STREET, PARIS, BOURBON COUNTY, KENTUCKY, WITH A ZONE MAP AMENDMENT FROM R-3 (RESIDENTIAL) TO B-1 (BUSINESS).

WHEREAS, the application for a zoning map amendment for property located at 1120 Main Street having been filed with the Paris-Bourbon County Joint Planning Commission (the "Joint Planning Commission") requesting a zoning classification change for 0.28 acres, more or less, from R-3 (residential) to B-1 (business) (the "Property"); and

WHEREAS, the application and this zone change amendment was presented to the Joint Planning Commission at its scheduled meeting on November 21, 2019 and with a quorum present, the Joint Planning Commission having voted to recommend approval of the zone change request of the Property; and

WHEREAS, the members of Board of Commissioners of the City of Paris, Kentucky have conducted a public hearing on February 11, 2020 and considered the entirety of the evidence presented at the public hearing,

NOW THEREFORE BE IT ENACTED AND ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF PARIS AS FOLLOWS:

Section 1: The Board of Commissioners adopts its own findings of fact which are attached as Exhibit A to this Ordinance and adopted as if fully made part of this Ordinance.

Section 2: Based upon the findings of fact attached as Exhibit A, a zoning map amendment from R-3 (residential) to (B-1) business for this Property is in agreement with the adopted comprehensive plan.

Section 3: Based upon the findings of fact attached as Exhibit A, the existing zoning classification of residential is inappropriate and the proposed zoning classification of business is appropriate.

Section 4: In accordance with KRS 100.211, the zoning map amendment of the Property is approved.

Section 5 - The Property hereby rezoned is more fully described as on the legal description attached as Exhibit B to this Ordinance.

Section 6 - The Zoning Ordinance shall be amended to show a change in the zoning classification for the Property from R-3 (residential) to B-1 (business).

Section 7 - The Paris-Bourbon County Joint Planning Commission is hereby directed to show the zoning classification change on the official zone map and to make reference to the number of this Ordinance.

Section 8 - If any provision of this Ordinance for any reason or to any extent, be invalid or unenforceable, the remainder of this Ordinance and the application of such provision to other persons or circumstances shall not be affected thereby, but rather shall be enforced to the greatest extent permitted by law.

This Ordinance was read for the first time on January 28, 2020 and read for the second time February 11, 2020.
