Mayor, John Plummer called the meeting to order and the Pledge of Allegiance was recited.

City Clerk, Stephanie Settles conducted roll call.

Present: Mayor, John A. Plummer; Commissioner, Wallis Brooks; Commissioner, Stan Galbraith; Commissioner, Anna Allen-Edwards.

Absent: Commissioner, Matt Perraut

Others in Attendance City Manager, Daron Jordan; Assistant City Manager, Mike Withrow; City Attorney, Bryan Beauman

Upon determining a quorum was present for the transaction of business, City Manager Daron Jordan, proceeded to conduct the meeting.

Motion by Brooks, seconded by Galbraith, approving municipal order 2020-7 concerning city commission meeting protocols for novel coronavirus (COVID-19). Motion carried by roll call vote of 4-0 with Brooks, Galbraith, Allen-Edwards and Plummer voting Aye.

CITY OF PARIS ORDER NO. 2020-7

A MUNICIPAL ORDER CONCERNING CITY COMMISSION MEETING PROTOCOLS FOR NOVEL CORONAVIRUS (COVID-19)

WHEREAS, on March 6, 2020, the Governor issued Executive Order 2020-215, declaring a state of emergency throughout Kentucky pursuant to his power under the Kentucky Constitution and KRS Chapter 39A regarding the threats to public health presented by the Novel Coronavirus (COVID-19) pandemic; and

WHEREAS, the Secretary of the Kentucky Finance and Administration Cabinet has more fully described the public health threats of COVID-19 in the "Memorandum Re: Meeting Protocol for Novel Coronavirus (COVID-19)" dated March 16, 2020 (hereinafter the: "Meeting Protocol"); and

WHEREAS, the Meeting Protocol requires "all Kentucky Boards and Commissions" to take proper health precautions to mitigate the spread of COVID-19 and accordingly, with respect to the public attendance at meetings of said bodies, states "[m]embers of the public will only be able to view video-teleconferenced meetings remotely;" and

WHEREAS, the same emergency public health considerations as described in the Meeting Protocol are relevant to Kentucky municipalities; and

WHEREAS, the Kentucky Cabinet for Health and Family Services and the Bourbon County Health Department have each advised that all Kentuckians practice "social distancing" during the state of emergency, including but not limited to keeping a distance of at least six (6) feet between individuals and the cancellation of large "community gatherings;" and

WHEREAS, the Kentucky Open Meetings Act at KRS 61.840 provides that "no condition other than those required for the maintenance of order shall apply to the attendance of any member of the public at any meeting of a public agency"; and

WHERAS, on March 18, 2020, the Kentucky Attorney General issued OAG 20-05 opining that it is not feasible under KRS 61.840 to precisely identify a primary physical location for a video teleconference at which the public may attend and view a public meeting conducted through video teleconference; and

WHEREAS, due to the emergency conditions currently existing under the present state of emergency and the need to mitigate the spread of COVID-19 via person-to-person contact in large community gatherings of persons where social distancing is difficult, the conditions necessary at this time for the maintenance of order, which include the mitigation of the spread of disease during a public health pandemic, at meetings of district boards of education include limitations on meeting attendance by members of the public such as described in the Meeting Protocol;

NOW THEREFORE be it resolved by the City Commission of the City of Paris; Kentucky as follows:

- 1. Meetings of the City of Paris Board of Commissioners have been streamed live on the City's Facebook page.
- 2. It is not feasible for the City to comply with the public health directives and best practices by continuing to allow in-person attendance at City Commission meetings.
- 3. Until such time as the state of emergency regarding the threats to public health presented by the Novel Coronavirus (COVID-19) pandemic is lifted by the Governor of the Commonwealth, or until such time as this Order is rescinded by subsequent municipal action, all meetings of the City of Paris Board of Commissioners held on March 24, 2020 and after the adoption of this Order, and subject to limited exceptions described below, shall be conducted in conformity with the procedures set forth in KRS 61.826 for video teleconferencing of meetings.
- 4. Commission members shall use their best efforts to observe any binding governmental directive or order that may be issued in the future to prohibit such attendance.
- 5. The City Manager shall arrange for resources and instructions necessary to allow Commission meetings to be conducted via video teleconferencing pursuant to KRS 61.826 and City policy:
- 6. Due to the circumstances previously described in this resolution, in the Governor's declaration of a state of emergency, and based upon the authority to impose conditions to maintain order under KRS 61.840 in these extraordinary and emergency circumstances, the requirement in KRS 61.826(2)(b) that the Commission provide a "primary location … where the public may attend" is suspended to the extent that provision requires an in-person meeting location.
- 7. Notices that regular or special meetings of the Commission are to be held as video teleconferences shall provide directions on public viewing of meetings via the internet. The City will provide members of the general public with notice and a video link to observe meetings. Provision of such link shall not otherwise interfere with the conduct of the meeting. Absent emergency circumstances qualifying under KRS 61.823(5), these notices shall be provided at least 24 hours before the video teleconference meeting.
- 8. Should there be an interruption in the public video or audio broadcast of the meeting, the meeting shall be suspended until the full

functionality is restored. If there is such an interruption for an individual member attending the meeting via video teleconference, the meeting may continue after reasonable efforts to restore connections so long as a quorum is still participating.

9. In the case of any Commission meeting involving individual hearing matters, including but not limited to personnel disciplinary hearings, consideration shall be made on a case-by-case basis for the holding of in-person meetings as deemed necessary and advisable and alternative arrangements to mitigate the spread of COVID-19 via person-to-person contact may be implemented.

Executive Order 2020-1 was read by City Attorney Bryan Beauman.

CITY OF PARIS EXECUTIVE ORDER NO. 2020-1

EXECUTIVE ORDER CONCERNING STATE OF EMERGENCY DECLARATION

WHEREAS, during a catastrophe or state of emergency, KRS 39A.020(3) defines the chief executive of home rule class cities as the Mayor, regardless of the form of government; and

WHEREAS, on March 13, 2020 President Donald J. Trump declared a national state of Emergency in response to the coronavirus, COVID-19, pandemic; and

WHEREAS, on March 6, 2020 Governor Andy Beshear declared a state of emergency in Kentucky in response to the first documented case of the novel coronavirus, COVID-19; and

WHEREAS, COVID-19, a respiratory disease that can result in serious illness or death and can easily spread from person; and

WHEREAS, the emergency response of the City of Paris must be deployed rapidly to protect the health, safety, and welfare of citizens; and

WHEREAS, Mayor Plummer has determined that the novel coronavirus, COVID-19, presents a severe and complex threat to the public health, safety, and welfare of citizens that extraordinary emergency measures are warranted pursuant to KRS 39A.100 (2) and KRS 39B.070; and

WHEREAS, it is necessary for Mayor Plummer to coordinate an emergency effort with national, state, county, and other local agencies for maximum effective response.

NOW and therefore, I, John A. Plummer, Mayor of the City of Paris, by virtue of the authority vested in me by KRS Chapter 39A and 39B of the Kentucky Revised Statutes, do hereby declare that a state of emergency exists in the City of Paris, and that I shall be exercising the authority granted to me through Kentucky law, City of Paris Executive Orders, and other lawful authority to utilize city personnel, services, equipment, and any necessary acts to manage this emergency.

Subject to any orders of Governor Andy Beshear, I hereby order and direct any and all departments of the City of Paris to coordinate and cooperate with the Bourbon County Health Department, Kentucky Department for Public Health, and any other federal, state, or local agencies to respond to the threat presented by COVID-19 by exercising the powers articulated in KRS Chapter 39A and 39B and to provide information to individuals, businesses, organizations, and other entities to best prepare and respond to the COVID-19 State of Emergency Declaration.

This Declaration of State of Emergency shall remain in effect until terminated by the issuance of another Executive Order when I determine that a state of emergency no longer exists and the exercise of extraordinary measures are no longer required for the protection of the public health, safety and welfare.

CITY OF PARIS ORDER NO. 2020-6

A MUNICIPAL ORDER CONCERNING LEAVE UNDER THE FAMILIES FIRST CORONAVIRUS RESPONSE ACT

WHEREAS, the President signed into law the "Families First Coronavirus Response Act" to assist with the impact of COVID-19 which provides that City employees may be eligible for additional leave under the law;

WHEREAS, to comply with the temporary leave requirement, the City of Paris is enhancing its leave policy for City employees,

NOW THEREFORE be it resolved by the City Commission of the City of Paris, Kentucky that

- 1. Pursuant to the Emergency Paid Sick Leave Act, all employees are eligible for two weeks of paid leave at their regular rate of pay for the following reasons. Eligible full-time employees will receive up to eighty (80) hours of paid sick leave. Eligible full-time members of the Fire Department will receive the commensurate hours of sick leave in accordance with their then established work schedule. It is the intent of the City to provide qualifying members of the Fire Department the typical amount of sick leave allowable under current City policy and likewise comply with the Act. Eligible part-time employees will receive pay based on the average number of hours worked over the last six months. The Act allows the employers to exclude healthcare providers and emergency responders from the definition of employees who are allowed to take such leave.
 - a. Subject to a federal, state or local quarantine or isolation order related to COVID-19;
 - b. Advised by a healthcare provider to self-quarantine due to COVID-19 concerns;
 - c. Experiencing COVID-19 symptoms and seeking medical diagnosis;
 - d. Caring for <u>an individual</u> subject to a federal, state or local quarantine or isolation order or advised by a healthcare provider to self-quarantine due to COVID-19 concerns (caring for another who is subject to an isolation order or advised to self-quarantine as described above is not limited to only family members).
 - e. Caring for the employee's child if the child's school or place of care is closed or the child's care provider is unavailable due to COVID-19 precautions; or
 - f. Experiencing any other substantially similar condition specified by the Secretary of Health and Human Services in consultation with the Secretary of the Treasury and the Secretary of Labor.

- 2. Pursuant to the Emergency Family Medical Leave Expansion Act (EFMLEA), an employee that has been employed for thirty (30) days or more is eligible for up to twelve (12) weeks of job-protected leave to allow the employee, who is unable to work or telework, to care for the employee's child (under 18 years of age) if the child's school or place of care is closed or the childcare provider is unavailable due to a public health emergency. The Act allows the employers to exclude healthcare providers and emergency responders from the definition of employees who are allowed to take such leave.
 - a. The first 10 days of EFMLEA-qualified leave are unpaid. An employee may either be eligible for Emergency Paid Sick Leave as outlined in paragraph 1. or may take other paid leave concurrently with the EFMLEA.
 - b. Beginning the third week of EFMLEA, an eligible employee shall be paid according to the following:
 - i. Full-time employees at two-thirds the employee's regular rate for the number of hours the employee would otherwise be normally scheduled. The EFMLEA limits this pay entitlement to \$200 per day and \$10,000 in the aggregate per employee.
 - ii. Employees who work a part-time or irregular schedule are entitled to be paid based on the average number of hours the employee worked for the six months prior to taking Emergency FMLA. Employees who have worked for less than six months prior to leave are entitled to the employee's reasonable expectation at hiring of the average number of hours the employee would normally be scheduled to work.
 - c. The City will return the employee to their prior position in accordance with the restoration requirements of the FMLA.
 - d. The City's FMLA leave is otherwise unchanged and any EFMLEA leave will count toward the employee's total twelve (12) weeks of job-protected FMLA leave.
- 3. The City Manager in consultation with the Director of Human Resources shall determine which employees are eligible for continued work or telework based on the needs and capacity of the City.
- 4. All other provisions of the City's Personnel Policies and Procedures shall remain in force.
- 5. This order will terminate at the expiration of the Families First Coronavirus Relief Act, currently set for December 31, 2020.

EXECUTIVE ORDER NO. 2020-2

EXECUTIVE ORDER CONCERNING CERTAIN CITY DEADLINES SCHEDULED BY CITY ORDINANCES

WHEREAS, during a catastrophe or state of emergency, KRS 39A.020(3) defines the chief executive of home rule class cities as the Mayor, regardless of the form of government; and

WHEREAS, on March 24, 2020, Mayor John A. Plummer declared a state of emergency for the City of Paris in response to the coronavirus, COVID-19, pandemic; and

WHEREAS, extraordinary emergency measures are warranted pursuant to KRS 39A.100 (2) and KRS 39B.070 to assist those who work and reside in the City or are City utility customers.

NOW and therefore, I, John A. Plummer, Mayor of the City of Paris, by virtue of the authority vested in me by KRS Chapter 39A and 39B of the Kentucky Revised Statutes, and Executive Order 2020-1 declaring a state of emergency in the City of Paris issue the following directives:

- 1. Paris Combined Utilities will offer flexible payment plans to customers who indicate either an impact or hardship as a result of COVID-19.
- 2. Until May 1, 2020, Paris Combined Utilities will not apply any late charges, interest or penalties for any utility customer unable to pay their bill in full by the payment deadline.
- 3. The disconnection of any customer of Paris Combined Utilities for non-payment of their utility bill is suspended.
- 4. All payroll license withholdings filing deadlines for the quarter ending March 31, 2020 will be extended for 30 days and will be due May 31, 2020 instead of April 30, 2020.
- 5. The City of Paris will follow the federal guidelines on tax returns for net profits by extending the filing and payment deadline until July 15, 2020.

This Executive Order shall remain in effect until the dates set out in this Executive Order or until terminated by the issuance of another Executive Order when I determine that a state of emergency no longer exists and the exercise of extraordinary measures are no longer required for the protection of the public health, safety and welfare.

Community Response to Public Health Emergency

Andrea Brown, MPH Public Health Director of the Bourbon County Health Department, provided an update related to coronavirus (COVID-19). Stated currently there are 415,000 cases across the world, 52,000 cases in the United States, 163 cases in Kentucky, and 2 cases in Bourbon County in which one is now deceased.

Fire Chief Michael Duffy discussed EMS is transporting approximately two citizens per day meeting the criteria of coronavirus (COVID-19) symptoms. With the current PPE and protocol in place no employees are quarantined.

Police Chief, Myron Thomas, reported an increase in domestic calls during the quarantine and continues to work with the Health Department to ensure businesses are operating by the Governors executive orders.

Superintendent Patrick Harney stated the wastewater plant is doing well with no issues to report. He reminded everyone to not flush any type of hand sanitation wipes into the sewer system.

City Attorney Bryan Beauman discussed the Atlas Street property is in the court system waiting to be approved. However, with the current closures of the court systems, due to coronavirus (COVID-19), this has delayed the deed transfer.

A MUNICIPAL ORDER APPROVING AN AMENDMENT TO A CONTRACT WITH STRAND ASSOCIATES, INC.

WHEREAS, on March 12, 2019, the City entered into a contract with Strand Associates, Inc., concerning professional services in the form of professional engineering review for a required Wastewater Treatment Plant Capacity, Management, Operations, and Maintenance Plan of Action; and

WHEREAS, that initial review identified action items required by the Kentucky Division of Water to taken by the City; and

WHEREAS, the City desires to amend its existing contact with Strand Associates, Inc., to include an additional scope of work and services consisting of those proposed to be addressed by the City on September 13, 2019 and set out in detail in the March 4, 2020 response by Stand Associates, Inc.

NOW THEREFORE, be it resolved by the City Commission of the City of Paris, Kentucky that the City's Contract with Strand Associates, Inc., be amended to include the February 2020 request for proposal by the City and the March 4, 2020 response by Strand Associates Inc., and that the Mayor is authorized to execute a revised Engineering Service Task Order upon the review and approval of City administrative staff.

AN ORDINANCE AMENDING BY CONSENT TO THE CITY BOUNDARY, PROPERTY OF PARIS-BOURBON COUNTY ECONOMIC DEVELOPMENT AUTHORITY, INC., WHICH PROPERTY IS ADJACENT TO THE CITY, URBAN IN NATURE AND SUITABLE FOR DEVELOPMENT WITHOUT UNREASONABLE DELAY, AND IS GENERALLY SITUATED ON CLEVELAND DRIVE WEST OF THE CITY BOUNDARY, CONTAINING 19.499 ACRES, MORE OR LESS.

WHEREAS, Paris-Bourbon County Economic Development Authority, Inc., as owners of approximately 19.499 acres, more or less, of property lying on Cleveland Drive and contiguous to the City limits of the City of Paris, has submitted a Consent to Annexation, pursuant to KRS 81A.412; and

WHEREAS, the City of Paris hereby declares that the unincorporated territory is subject to annexation pursuant to KRS 81A.410 NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PARIS BOARD OF COMMISSIONERS AS FOLLOWS:

Section 1. That the City of Paris hereby annexes to the City boundary that certain tract of land west of the City, containing 19.499 acres, more or less, which property is owned by Paris-Bourbon County Economic Development Authority, Inc.

Section 2. That the property is adjacent and contiguous to the City, by reason of contiguous industrial property urban in nature, and suitable for development for urban purposes without unreasonable delay, and it is desirable for the City to annex such tract.

Section 3. That Paris-Bourbon County Economic Development Authority, Inc., as the owner of record for the property to be annexed, according to the deed of record in the Office of the Bourbon County Court Clerk, consents to and has requested the City of Paris to annex its property, has formally requested that said property be annexed as evidenced by the attached "Consent to Annexation," identified as Exhibit A and incorporated herein by reference.

Section 4. That the tract to be annexed is more particularly described in the Exhibit included with the "Consent to Annexation" and identified as "Parcel 1" on Exhibit B, City of Paris Annexation Plat, attached hereto and incorporated herein by reference.

Section 5. That the initial zoning of said property shall be I-1, as recommended by the Bourbon County Joint Planning Commission following a public hearing on February 20, 2020.

Section 6. This Ordinance shall become effective upon its passage, publication, and recording as required by law.

Introduced on First Reading: Regular Meeting, November 26, 2019 Adopted on Second Reading: Regular Meeting, March 24, 2020 First reading of an ordinance enacting and adopting a supplement to the Code of Ordinances was read by Bryan Beauman. No action was taken, second reading will be at the next regular scheduled meeting.
