Paris City Commission 525 High Street Paris, KY 40361 Meeting Minutes November 9, 2021

The Paris City Commission met in regular session at 9:00 a.m. viewable on Facebook live at www.facebook.com/cityofparisky on Tuesday, November 9, 2021.

Mayor, Plummer called the meeting to order, and the Pledge of Allegiance was recited.

City Clerk Stephanie Settles conducted roll call.

Present: Mayor, John Plummer Commissioner, Wallis Brooks; Commissioner, Holli Gibson; Commissioner, Stan Galbraith; Commissioner, Angela Roberts.

Others in Attendance: Interim City Manager, Mike Withrow; City Attorney, Bryan Beauman; CPA, Brad Oberlander; and City Clerk, Stephanie Settles.

Upon determining a quorum was present for the transaction of business, Interim City Manager Mike Withrow proceeded to conduct the meeting.

Approval of Minutes

Motion by Brooks, seconded by Gibson, to approve the regular meeting minutes of the October 26, 2021, meeting. Motion carried by roll call vote of 5-0 with Plummer, Brooks, Roberts, Galbraith, and Gibson voting Aye.

Presentation

Stephen McCauley requested The City of Paris financial assistance to place an SRO officer within the Paris Independent School System. The city commission was in favor of exploring options along with Chief Thomas. A proposal will be drafted for review.

New Business

Betty Ann Allen discussed Horse drawn carriage rides downtown for the holidays, and the commission was in support of carriage rides noting that the entity must obtain proper licenses and insurance.

Motion by Plummer, seconded by Roberts, approving the street closure from Bourbon County High School to the Bourbon County Court House on Saturday, December 4, 2021, from 5:30 p.m. for the annual Chamber of Commerce Christmas parade. Motion carried by roll call vote of 5-0 with Plummer, Brooks, Roberts, Galbraith, and Gibson voting Aye.

Motion by Plummer, seconded by Brooks, authorizing the mayor to sign a renewal lease agreement for Hope Park with Janet's Investments, LLC. Motion carried by roll call vote of 5-0 with Plummer, Brooks, Roberts, Galbraith, and Gibson voting Aye.

First reading of a budget amendment for CBDG grant funds was read by Brad Oberlander.

Bryan Beauman discussed the OSHA emergency temporary stand regarding COVID-19 vaccination and/or testing requirements. Stating it is a vaccinate or test mandate, federal rules begin January 4, 2022. Erin Morton stated she would have a policy in place by December 5th, 2021 and will continue to follow the federal mandates.

Motion by Brooks, seconded by Plummer, authorizing the city to submit a loan to KIA for Paris water system improvements project number WX21017022 for the loan amount of \$ 3,275,000. Motion carried by roll call vote of 5-0 with Plummer, Brooks, Gibson, Galbraith, and Roberts voting Aye.

Bryan Beauman indicated the Clough property contract has been drafted; and the plat will be reviewed by the planning commission technical review committee on November 22nd.
