Mayor, Plummer called the meeting to order, and the Pledge of Allegiance was recited.

Upon determining a quorum was present for the transaction of business, Interim City Manager Mike Withrow proceeded to conduct the meeting.

#### **Approval of Minutes**

Motion by Brooks, seconded by Roberts to approve the regular meeting minutes of the December 6, 2021, meeting. Motion carried by roll call vote of 5-0 with Plummer, Brooks, Roberts, Galbraith, and Gibson voting Aye.

#### **Public Comment**

Lyra Miller owner of Lill's Restaurant discussed Main Street Road closures and why downtown merchants are not notified of the closures. Mike Withrow stated that Main Street is a state road, that a state encroachment permit is required by the state, the state does not notify the city when they receive closure permits.

## **New Business**

Motion by Plummer, seconded by Brooks, approving municipal order 2021-25 COVID-19 Premium Pay. Motion carried by roll call vote of 5-0 with Plummer, Brooks, Roberts, Galbraith, and Gibson voting Aye.

CITY OF PARIS KENTUCKY MUNICIPAL ORDER 2021-25

## A MUNICIPAL ORDER APPROVING A COVID-19 PREMIUM PAY

FOR ESSENTIAL EMPLOYEES WHEREAS, pursuant to the Order of the President of the United States and the Governor of Kentucky, the City of Paris has declared a state of emergency due to the COVID-19 public health crisis:

WHEREAS, the Board of Commissioners declares certain positions as essential to maintaining the continuity of essential operations to the citizens of Paris;

WHEREAS, almost all City employees are either directly involved in the provision of those essential services or are critical to maintaining the continuity of those operations by making sure everyone is paid adequate funds exist to do their jobs.

WHEREAS, the American Rescue Plan Act encourages premium pay for employees of an employer who continued to operate as an essential business throughout the public health emergency; and

NOW THEREFORE, BE IT ORDERED by the City of Paris as follows:

- 1. The following position are declared essential and are thereby eligible for premium pay as approved by the Paris City Commission:
  - a. All positions within Paris Fire Department including all employees providing emergency medical services.
  - b. All positions within Paris Police Department including all employees providing Enhanced 911 dispatch services.
  - c. All positions within Paris Combined Utilities including powerplant, electric distribution, water plant, water distribution, wastewater treatment, and sanitation.
  - d. All positions within Paris Public Works Department.
  - e. All administrative positions whose primary function is to support the day-to-day operation of the city government.
- 2. All essential employees will receive a one-time premium pay of  $0.70\/\$  for all hours worked between April 1, 2020-March 31, 2021.
- 3. The premium pay will be calculated on actual hours worked and will not include vacation, sick, personal, compensatory time, or any other time when the employee was not at work, whether paid or unpaid. Premium pay will not be paid for hours spent working from home.
- 4. The premium pay will be subject to all local, state and federal taxes, the applicable Kentucky retirement system, and any other deduction as required by law.
- 5. Only employees currently employed by the City of Paris will be eligible for premium pay.

Motion by Galbraith, seconded by Brooks approving the purchase of a 2022 1500 SLT Crew Cab 4x4 for \$41,789.00 from Dan Cummins to be used at the utility truck for the Fire Department. Motion carried by roll call vote of 5-0 with Plummer, Brooks, Roberts, Galbraith, and Gibson voting Aye.

Motion by Plummer, seconded by Brooks, approving a municipal order relating to participation in the national opioid settlement. Motion carried by roll call vote of 5-0 with Plummer, Brooks, Roberts, Galbraith, and Gibson voting Aye.

### CITY OF PARIS ORDER 2021-24

# A MUNICIPAL ORDER RELATING TO PARTICIPATION IN THE NATIONAL OPIOID SETTLEMENT

WHEREAS, the opioid epidemic has had devastating consequences on our Commonwealth and on the City of Paris;

WHEREAS, the latest report from the Kentucky Office of Drug Control Policy revealed that in 2020 1,964 Kentuckians lost their lives as a result of overdose, nearly a 50% increase from 2019;

WHEREAS, in 2020 an opioid was involved in 90% of the 1,964 overdose deaths;

WHEREAS, the COVID-19 pandemic has exacerbated the damage caused by the ongoing opioid crisis;

**WHEREAS**, in response, the Kentucky Attorney General has pursued litigation against opioid manufacturers and distributors, including AmerisourceBergen, Cardinal Health, McKesson, and Johnson & Johnson;

WHEREAS, in cooperation with the Kentucky Association of Counties, the Kentucky League of Cities, and local governments, the General Assembly unanimously passed and the Governor signed House Bill 427 of the 2021 Regular Session;

WHEREAS, House Bill 427 has been codified as KRS 15.291 and 15.293;

WHEREAS, House Bill 427 provides a plan for how to distribute funds from a final settlement with AmerisourceBergen, Cardinal Health, McKesson, and Johnson & Johnson;

WHEREAS, on July 21, 2021, Kentucky became a Settling State in the litigation against AmerisourceBergen, Cardinal Health, McKesson, and Johnson & Johnson:

**WHEREAS**, in the event of a final settlement, House Bill 427 releases all opioid-related claims against AmerisourceBergen, Cardinal Health, McKesson, and Johnson & Johnson;

WHEREAS, in exchange for this release, the Commonwealth receives the maximum amount of settlement funds available under the settlement agreements;

WHEREAS, these settlement funds will be split 50/50 between the Commonwealth and participating local governments;

WHEREAS, local governments may participate in the settlement by signing-up on the national opioid website; and WHEREAS, local governments that fail to sign-up risk not qualifying as a participating local government, which is necessary for direct payments from opioid abatement funds.

**NOW, THEREFORE**, it is ORDERED by the Board of Commissioners of the City of Paris that the local government of Paris, Kentucky desires to join the national opioid settlement and authorizes the Mayor to take all steps necessary to join the settlement.
