Approval of Minutes

Motion by Gibson, seconded by Roberts to approve the special meeting minutes of the December 21, 2021, meeting. Motion carried by roll call vote of 4-0 with Plummer, Brooks, Galbraith, and Gibson voting Aye.

New Business

Motion by Galbraith, seconded by Gibson approving municipal order 2021-25 approving an addendum to the Rumpke solid waste and recycling collection contract. Motion carried by roll call vote of 4-0 with Plummer, Gibson, Galbraith, and Roberts voting Aye.

A MUNICIPAL ORDER APPROVING A WRITTEN ADDENDUM TO THE CONTRACT WITH RUMPKE OF KENTUCKY, INC. FOR SOLID WASTE AND RECYCLING COLLECTION

WHEREAS, the City has previously entered into a written contract regarding curbside solid waste and recycling collection with Rumpke of Kentucky, Inc. which allows for an extension of the terms;

NOW THEREFORE, be it resolved by the City Commission of the City of Paris, Kentucky that the proposed and attached written addendum to the contract with Rumpke of Kentucky, Inc. memorializes the agreement previously reached and that the Mayor is directed the execute the written addendum

WHEREAS, the City has agreed to enter into a written contract regarding the use of a certain City utility easement;

Gibson stated HR audits are recommended every couple years and is not encompassed as part of the annual financial audit that is done annually. The commission requested additional information on specifically what documents are audited.
