CALL TO ORDER

SPECIAL PRESENATIONS

State Representative Matthew Koch discussed the 2024 legislative priorities.

ORDINANCES

First reading of Ordinance 2023-16 related to an amendment to the compensation pay scale was read. The ordinance and related exhibit of the compensation schedules moves the Administrative, Electric, and Operation compensation schedule by approximately 2.5%. Employees whose positions are on these schedules would be placed within the new scales at their current step and receive an adjustment.

The Police and Fire Compensation Schedules are part of the exhibit to keep the document complete, but they did not change. Dispatch employees and the Police Safety Office are part of the police schedule, but not sworn personnel impacted by the Hazardous Duty retirement. The staff recommend that even though their scale is not moving, employees within the dispatch and public safety officer positions move a step within the scale. This would allow them to receive a similar estimated increase as other non-police and fire personnel.
