The Paris City Commission met in a regular session at 9:00 a.m. on Tuesday, August 22, 2017.

Mayor, Michael Thornton, called the meeting to order and the Pledge of Allegiance was recited.

City Clerk, Stephanie Settles, conducted roll call. The following were present: Mayor, Michael Thornton, Commissioner, Matt Perraut, Commissioner, Wallis Brooks (arrived at 9:10 a.m.), Commissioner, Tim Gray, Commissioner, Michael Kendall, City Manager, Daron Jordan, Assistant City Manager, Mike Withrow, City Attorney, Bryan Beauman, City Clerk & Treasurer, Stephanie Settles.

Upon determining a quorum was present for the transaction of business, City Manager, Daron Jordan proceeded to conduct the meeting.

**Approve Minutes**

Motion by Gray, seconded by Perraut, to approve minutes of August 8, 2017 Regular Meeting. The motion carried by roll call vote of 5-0 with Kendall, Gray, Brooks, Perraut, and Thornton voting Aye.

**Public Comment**

Steve Baker submitted a petition signed by seven neighbors; along with 11 photos of a dilapidated property located at 146 Virginia Avenue. The petition requested the City's help to find a solution to the property's condition issues.

Motion by Kendall, seconded by Perraut, to allow Mike Withrow, Assistant City Manager to work with the Fire Chief to abate the property hazard within KRS guidelines. Motion by Thornton, seconded by Brooks, the motion carried by roll call vote of 5-0 with Kendall, Gray, Brooks, Perraut and Thornton voting Aye.

Sharon Patterson discussed her concerns with the \$ 10.75 electric meter fee; stating the meter fee creates additional financial hardship on those with a fixed income.

**RESOLUTION 2017-14  
CITY OF PARIS, KENTUCKY**

**A RESOLUTION CONCERNING THE KENTUCKY EMPLOYEE RETIREMENT SYSTEM.**

**WHEREAS**, The City of Paris has employees invested in the County Employees Retirement System;

**WHEREAS**, the County Employees Retirement System is currently funded at 62 percent, a higher funded ratio than it was prior to passage of SB2;

**WHEREAS**, the Kentucky Employees Retirement System is the worst funded system in the U.S. and was noted by R.V. Kuhns, Inc. as being set to undergo financial hurdles of “persistent funding shortfalls, elevated contribution levels, unsustainable payout ratios and in the worst-case scenario, the potential for the complete depletion of the asset base”;

**WHEREAS**, total assets of the County Employees Retirement System are about \$12 billion, 73 percent of the total Kentucky Retirement Systems’ assets;

**WHEREAS**, administrative costs for the Kentucky Retirement Systems have increased 245 percent since 2000, and the County Employees Retirement System pays 63 percent of those costs;

**WHEREAS**, separation of the County Employees Retirement System would result in the creation of a new nine-member board whose sole responsibility would be the management of the County Employees Retirement System;

**WHEREAS**, the current 17-member Kentucky Retirement Systems Board of Trustees has only six seats for County Employees Retirement System representatives, and the Kentucky Retirement Systems Board of Trustees Investment Committee has no representative from the County Employees Retirement System;

**WHEREAS**, separation of the County Employees Retirement System from the Kentucky Retirement Systems would mean local control of local pensions and would ensure the needs of the County Employees Retirement System are met so it can continue its current path of growth for years to come;

**NOW, THEREFORE, BE IT RESOLVED** That the Paris City Commission of the City of Paris supports the separation of the County Employees Retirement System from the Kentucky Retirement Systems.
