## **Approve Minutes**

#### **Old Business/Action Items**

Motion by Thornton, seconded by Perraut, authorizing the Mayor to sign a Letter of Match Commitment in the amount of \$37,030.00 in cash to complete the construction of the proposed Safe Routes to School project, and the Transportation Alternative Program Grant Application. The motion carried by roll call vote of 5-0 with Kendall, Gray, Brooks, Perraut, and Thornton voting Aye.

City Manager, Daron Jordan discussed multiple cases of theft of utility services, and excessive unpaid utility bills dating back to 1999. Jordan discussed proposed ideas and suggestions requesting the current Ordinance be updated. City Attorney Bryan Beauman will draft an Ordinance addressing the concerns and submit at the next meeting for review.

# TOBACCO AND RELATED PRODUCTS

The use of tobacco shall be prohibited in any city vehicle or equipment, inside any structure owned or in the possession of the City, and anywhere outdoors on the premises of 525 High Street except for the locations where the City may designate certain indoor or outdoor areas where tobacco products may be consumed, or where the terms of any lease specify. For purposes of this policy, "tobacco" includes cigarettes, cigars, pipes, smokeless tobacco, oral tobacco products, electronic cigarettes and any other products that permit vapor solutions with or without the use of tobacco products.

Motion by Thornton, seconded by Perraut, approving a 3MM policy thru KACO for the Joint Paris -Bourbon County Planning and Zoning department with an annual premium cost of \$ 12,000.
