The Paris City Commission met in a regular session at 9:00 a.m. on Wednesday, December 19, 2018.

Mayor, Michael Thornton, called the meeting to order and the Pledge of Allegiance was recited.

City Clerk, Stephanie Settles conducted roll call.

Old Business

Motion by Kendall, seconded by Perraut, approving financing of \$ 275,297.00 thru Kentucky Bank for the purchase of 10 Dodge police vehicles at 36 monthly payments of \$ 8,187.39. Motion carried by roll call vote of 5-0 with Kendall, Gray, Perraut and Thornton voting Aye, Brooks abstained from the vote.

Executive Session

Motion by Kendall, seconded by Perraut, to go into executive session at 9:04 a.m. pursuant to KRS 61.810(1)(b), and (g) Deliberations on the sale of real property by a public agency, but only when publicity would be likely to affect the value of a specific piece of property to be acquired for public use or sold by a public agency. Discussions between a public agency and a representative of a business entity and discussions concerning a specific proposal, if open discussions would jeopardize the siting, retention, expansion, or upgrading of the business at 9:04 a.m. Motion carried by roll call vote of 5-0 with Kendall, Gray, Brooks, Perraut and Thornton voting aye.

Motion by Kendall, seconded by Brooks, to exit executive session at 9:27 a.m. and resume regular session. Motion carried by roll call vote of 5-0 with Kendall, Gray, Brooks, Perraut and Thornton voting aye.

Motion by Kendall, seconded by Gray, authorizing the Mayor and City Manager to have further discussions with a business entity and to consider drafting a document for this body's consideration for the potential conveyance of real property for economic development purposes. Motion carried by roll call vote of 5-0 with Kendall, Gray, Brooks, Perraut and Thornton voting aye.

Motion by Kendall, seconded by Gray, approving a special called meeting on December 28th, 2018 at 9:00 a.m. at 525 High Street in the City Commission Chambers. Motion carried by roll call vote of 5-0 with Kendall, Gray, Brooks, Perraut and Thornton voting aye.
