Paris City Commission Commission Chambers Paris, Kentucky November 13, 2018

The Paris City Commission met in a regular session at 9:02 a.m. on Tuesday, November 13, 2018.

Mayor Michael Thornton, called the meeting to order and the Pledge of Allegiance was recited.

City Clerk, Stephanie Settles conducted roll call.

**Present:** Mayor, Michael Thornton, Commissioner, Matt Perraut, Commissioner, Wallis Brooks, Commissioner, Michael Kendall.

Absent: Commissioner, Tim Gray.

Others in Attendance City Manager, Daron Jordan, Assistant City Manager, Mike Withrow, City Attorney, Bryan Beauman, City Clerk/Treasurer, Stephanie Settles.

Upon determining a quorum was present for the transaction of business, City Manager, Daron Jordan proceeded to conduct the meeting.

#### **Approve Minutes**

Motion by Kendall, seconded by Perraut, approving the minutes of October 23, 2018 regular meeting. Motion carried by roll call vote of 4-0 with Kendall, Brooks, Perraut and Thornton voting Aye.

#### **Old Business**

City Manager, Daron Jordan discussed renovations for multiple locations within city hall, converting an area in the basement to a training area, improvement of the commission chambers audio and visual, and third floor renovations for the police department. A proposal of plans will be presented to the commission for approval before construction begins.

Motion by Kendall, seconded by Brooks, allowing staff to go into competitive negations with the sole bidder Altec Inc for the build of a Altec model AT41P articulating telescopic aerial bucket truck for the Electric Department. Motion carried by roll call vote of 4-0 with Kendall, Brooks, Perraut and Thornton voting Aye.

City Attorney, Bryan Beauman discussed the Columbia Gas franchise agreement. Bryan discussed that Frankfort provided their Ordinance showing how they have implemented terms, permitting, street cut bonding etc....within their city ordinances. Copies of the Frankfort Ordinances was provided to council for review and it was determined that Bryan will move forward and begin working on updates to the City of Paris Ordinances.

Assistant City Manager, Mike Withrow stated in discussion with Hinkle Contracting it was determined the 2018 street paving project will be postponed until spring 2019 because due to weather conditions. The streets that need cold patch will be patched accordingly until they can be paved.

City Manager, Daron Jordan discussed an Energy Performance Contracting pre-bid meeting will be scheduled the last week of November.

City Manager, Daron Jordan discussed the transition to Rumpke. Residents will receive a mailer from Rumpke discussing the change effective December 3, 2018. Daron stated Rumpke representatives have been visiting businesses to discuss the transition of services. City wide recycling will be expanded to all city residents and multiple recycling drop off locations will be established around town.

CPA, Brad Oberlander, discussed the FY18 audit has begun with an anticipated rough draft to be submitted to commission for review at the first meeting in January 2019.

Motion by Brooks, seconded by Kendall, approving a Municipal Order concerning an agreement for lease and re-purchase of real property. Motion carried by roll call vote of 4-0 with Kendall, Brooks, Perraut and Thornton voting Aye.
