Paris City Commission 525 High Street Paris, KY 40361 Meeting Minutes August 13, 2019

The Paris City Commission met in regular session in the City Commission Chambers at 9:00 a.m. on Tuesday, August 13, 2019.

Mayor, Johnny Plummer called the meeting to order and the Pledge of Allegiance was recited.

City Clerk, Stephanie Settles conducted roll call.

Present: Mayor, Johnny Plummer; Commissioner, Matt Perraut; Commissioner, Wallis Brooks; Commissioner, Stan Galbraith; Commissioner, Anna Allen-Edwards.

Others in Attendance City Manager, Daron Jordan, Assistant City Manager, Mike Withrow, Attorney, Bryan Beauman.

Upon determining a quorum was present for the transaction of business, City Manager Daron Jordan, proceeded to conduct the meeting.

## **Approve Minutes**

Motion by Galbraith, seconded by Perraut, approving the minutes of July 9, 2019 regular meeting. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

#### **Old Business**

Second reading of Ordinance 2019-7 amending the City zoning ordinance relating to a Joint Board of Adjustment was read by Bryan Beauman. Motion by Mayor Plummer, seconded by Galbraith approving Ordinance 2019-7. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

CITY OF PARIS, KENTUCKY ORDINANCE NO. 2019-7

#### AN ORDINANCE AMENDING THE CITY ZONING ORDINANCE RELATING TO A JOINT BOARD OF ADJUSTMENT

WHEREAS, the Board of Commissioners has previously resolved to support the creation of a joint Board of Adjustment with the City of North Middletown and Bourbon County; and

WHEREAS, Paris-Bourbon County Joint Planning Commission has recommended the adoption of an amendment to the City of Paris Zoning Ordinance to create a joint Board of Adjustment,

NOW THEREFORE BE IT ENACTED AND ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF PARIS AS FOLLOWS:

Section I. Section 80.008 of the City of Paris Code of Ordinance shall be amended as follows:

## 80.008 DEFINITIONS

"BOARD." The Paris Board of Adjustment, unless the context indicates otherwise.

"BOARD OF ADJUSTMENT" OR "BOARD" The Joint Board of Adjustment having jurisdiction over unincorporated Bourbon County, City of Paris, and the City of North Middletown in accordance with the amended interlocal agreement for a joint planning unit.

Section II. Section 80.301 of the City of Paris Code of Ordinances shall be repealed in its entirety as replaced as follows:

#### 80.301 THE BOARD OF ADJUSTMENT

#### A. Creation and procedure.

1. A Joint Board of Adjustment having jurisdiction over the City of Paris, city of North Middletown and unincorporated area of Bourbon County, is hereby established to include the City of North Middletown, City of Paris, and unincorporated County, which shall consist of five (5) members two (2) appointed by the Mayor of the City of Paris and approved by the Paris City Commission, one (1) appointed by the Mayor of the City of North Middletown and approved by the North Middletown City Commission, and two (2) appointed by the Bourbon County Judge-Executive and approved by the Fiscal Court. All members shall be citizen members appointed by the legislative body, each for a period of four (4) years, and members of the Board may be removed from office by the legislative body for cause upon written charges and after public hearing. Vacancies shall be filled by the legislative body for the unexpired term of the member affected. To be eligible for appointment to the Board, a citizen must be (1) age twenty-five (25) or older; (2) a high school graduate or equivalent; (3) a City of Paris property owner; (4) registered voter and (5) a current resident of the City of Paris for one (1) year or more. The term of office of the initial members shall be staggered as provided for in the Interlocal Agreement and in KRS 100.217(4).

- 2. Meeting of Board; quorum; minutes; bylaws.
- (a) The Board shall conduct meetings at the call of the chairperson, who shall give written or oral notice to all members of the Board at least seven (7) days prior to the meeting; which notice shall contain the date, time and place for the meeting, and the subject or subjects which will be discussed.
- (b) A simple majority of the total membership of the Board as established by regulation or agreement shall constitute a quorum. Any member of the Board who has any direct or indirect financial interest in the outcome of any question before the body shall disclose the nature of the interest and shall disqualify himself or herself from voting on the question.
- (c) The Board may adopt bylaws for the transaction of business and shall keep minutes and records of all proceedings, including regulations, transactions, findings, determinations, the number of votes for and against each question, and if any member is absent or abstains from voting indicating the fact. All of the aforementioned minutes and records shall, immediately after adoption, be filed in the Bourbon County Joint Planning Office. A transcript of the minutes of the Board shall be provided if requested by a party, at the expense of the requesting party, and the transcript shall constitute the record.

## 3. Appeals to the Board

- (a) Procedure for all appeals to board. Appeals to the Board may be taken by any person, or entity claiming to be injuriously affected or aggrieved by an official action, order, requirement, interpretation, grant, refusal, or decision of any zoning enforcement officer. Such appeal shall be taken in accordance with the procedures and time limitations set forth in KRS 100.261, as amended.
- (b) Public notice of appeal hearing. The Board shall fix a reasonable time for hearing the appeal and give public notice in accordance with KRS Ch. 424, as well as written notice to the appellant and the administrative official, at least one (1) week prior to the hearing, and shall decide it within sixty (60) days. The affected party may appear at the hearing in person or by attorney.
- (c) Stay of proceeding. An appeal stays all proceedings in furtherance of the action appealed from, unless the administrative official from whom the appeal is taken certifies to the Board after the notice of appeal is filed with him or her, that the reason of facts stated in the certificate, a stay would, in his or her opinion, cause eminent peril to life or property. In such case, proceedings shall not be stayed except by a restraining order which may be granted by the Board or by a court of record of application, and no notice to the administrative official from whom the appeal is taken and on due cause shown.

## B. Powers and Duties of the Board.

- 1. Conditional use permits.
- (a) The Board shall have the power to hear and decide applications for conditional use permits in accordance with KRS 100.237, as amended. The Board shall have the power to hear and decide applications for conditional use permits to allow the proper integration into the community of uses which are specifically named in the zoning regulations as permissible only in specific locations in the district or only if certain conditions are met.
- (b) Notice of the hearing shall be posted conspicuously on the property which is considered for the conditional use permit. Signage shall be posted for fourteen (14) consecutive days immediately prior to the hearing. Posting shall be as follows: The sign shall state "conditional use permit" and the proposed use in letters three (3) inches in height. The time, place, and date of hearing shall be in letters at least one (1) inch in height. The sign shall be constructed of durable material and shall state the telephone number of the Bourbon County Joint Planning Office. It shall be the responsibility of the applicant to post the sign, provided by the Planning Office conspicuously on the property. The administrator shall verify to the Board at the hearing that placement occurred. The Planning Office shall provide the required signage for use by the property owner. Signage shall be returned no later than five (5) days after the public hearing.

## 2. Dimensional variance.

- (a) The Board shall have the power to hear and decide applications for variances.
- (b) Notice of the hearing shall be given at least seven (7) days in advance of the hearing by first class mail, with certification by the Board administrator that the notice was mailed to an owner of every parcel of property adjoining the property and the proposed variance request.
- (c) Notice of the hearing shall be posted conspicuously on the property which is considered for the dimensional variance. Signage shall be posted for seven (7) consecutive days immediately prior to the hearing. Posting shall be as follows: The sign shall state "Variance Request" in letters three (3) inches in height. The time, place, and date of hearing shall be in letters at least one (1) inch in height. The sign shall be constructed of durable material and shall state the telephone number of the Bourbon County Joint Planning Office. It shall be the responsibility of the applicant to post the sign, provided by the Planning Office conspicuously on the property. The administrator shall verify to the Board at the hearing that placement occurred. The Planning Office shall provide the required signage for use by the property owner. Signage shall be returned no later than five (5) days after the public hearing.
- (d) When a proposed development requires one (1) or more variances, the Planning Commission may hear and finally decide applications for variances at the same hearing. The applicant for a development, at the time of the filing of the application for the development, may elect in writing to the administrative official to have any variances for the same development to be heard and finally decided by the Planning Commission at the same public hearing set for the development.

- 3. Administrative review. The Board shall have the power to hear and decide cases where it is alleged by an applicant that there is error in any order, requirement, decision, grant, or refusal made by an administrative official in the enforcement of the zoning regulations, under the procedure set out in Sections 80.301.A(3).
- 4. Lot of record. On application for a lot of record, the Board shall grant only such variances as close as possible to the requirements of the district to not deprive the owner of the reasonable use of the property.
- C. Compensation. The members of the Board of Adjustment shall be paid a salary of seventy-five (\$75.00) dollars per meeting that is attended.

Section III. Section 80.302 of the City of Paris Code of Ordinances shall be repealed in its entirety and replaced as follows:

#### § 80.302 APPEALS FROM COMMISSION OR BOARD OF ADJUSTMENT

All appeals from any final action of the Planning Commission or Board of Adjustment shall conform to the requirements of KRS 100.347, as amended.

This Ordinance was read for the first time on July 9, 2019 and read for the second time on August 13, 2019 and becomes effective on the date of its publication.

If any provision of this Ordinance for any reason or to any extent, be invalid or unenforceable, the remainder of this Ordinance and the application of such provision to other persons or circumstances shall not be affected thereby, but rather shall be enforced to the greatest extent permitted by law.

Commissioner Allen-Edwards requested term limits to be established for BOA board appointments. It was discussed and determined that City Attorney Bryan Beauman will draft an Ordinance for the next meeting establishing board term limits for all City of Paris appointed board members.

Motion by Allen-Edwards, seconded by Brooks, authorizing the Mayor to enter into an agreement subject to the approval of the agreement by the City Attorney with MagneGrip Group to provide and install a fully automatic MagneGrip diesel exhaust extraction system in Fire Station #1 for \$ 35,060.00 and Fire Station #2 for \$ 46,721.00 for a total of \$ 81,781.00. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

Daron Jordan discussed an RFP for Engineering Services for the Water and Waste Water Systems evaluation had been published and currently working with engineering firms and the state association. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

## Mike Withrow

- Reported that the street paving is complete, stating 20 streets were paved.
- Stated possible litigation ahead for the Legion Drive building as quality and workmanship is an issue.

Motion by Brooks, seconded by Perraut, approving the bid of a 1999 Vacuum Truck for \$ 2,000.00 and a 1994 Trailer Jet Rodder for \$ 2,500 to Buchanan Contracting Inc. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

#### Daron Jordan

- ClearGov has completed the initial set up of the Paris City Government Transparency information center. The information is accessible by the public at any time, the information is on the City website homepage.
- Apprentice Program with the schools is in motion, job descriptions are being written and students are being identified and interviewed

Bryan Beauman discussed the revisions to the Code of Ordinances review is ongoing. Updates and revisions to the code will be presented one at a time to the Commission for review at future meetings.

## **New Business**

First reading of an Ordinance related to levying the City of Paris ad valorem taxes for general municipal purposes for the fiscal year of 2019-2020 on real property within the taxing jurisdiction of the City of Paris shall be at the rate of \$0.113 per one hundred (\$100.00) dollars of assessed valuation was read by Bryan Beauman.

First reading of an Ordinance related to levying the City of Paris ad valorem taxes for general municipal purposes for the fiscal year of 2019-2020 on personal property, other than motor vehicles and watercraft, within the taxing jurisdiction of the City of Paris shall be at the rate of \$0.1464 per one hundred (\$100.00) dollars of assessed valuation was read by Bryan Beauman.

First reading of an Ordinance related to levying the City of Paris ad valorem taxes for general municipal purposes for the calendar year of 2020 on motor vehicles and watercraft within the taxing jurisdiction of the City of Paris shall be the rate of \$0.17 per one hundred (\$100.00) dollars of assessed valuation was read by Bryan Beauman.

Motion by Galbraith, seconded by Perraut, approving Municipal Order 2019-19 approving an amendment to the contract with the Kentucky Municipal Energy Agency. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

Motion by Perraut, seconded by Galbraith, authorizing the City Attorney to perform due diligence needed to ensure a clear title to property and to accept offer proposed by Stella Moore to purchase her property on Elizabeth Street for \$ 3,500.00 . Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

Motion by Mayor Plummer, seconded by Brooks, authorizing to extend the current lease agreement of office space to the Kentucky Finance and Administration Cabinet to expire on June 20, 2021. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.

Motion by Mayor Plummer, seconded by Perraut, approving to change the time of September 10, 2019 Regular Meeting to a Special Meeting at 6:00 p.m. the meeting on September 24, 2019 will begin at 9:00 a.m. Change the time of December 10, 2019 Regular Meeting to a Special Meeting at 6:00 p.m. Motion carried by roll call vote of 5-0 with Allen-Edwards, Galbraith, Brooks, Perraut and Plummer voting Aye.
