Meeting Minutes

The Paris City Commission met in special session in the City Commission Chambers at 9:00 a.m. on Friday, February 14, 2020.

Mayor, John Plummer called the meeting to order.

City Clerk, Stephanie Settles conducted roll call.

Upon determining a quorum was present for the transaction of business, Mayor Plummer, proceeded to conduct the meeting.

Business

Motion by Perraut, seconded by Brooks, approving closure of the 6th Street parking lot from Thursday, April 16th thru Sunday, April 19th for a Chamber of Commerce Festival. Motion carried by roll call vote of 5-0 with Plummer, Perraut, Brooks, Galbraith and Allen-Edwards voting Aye.

Motion by Perraut, seconded by Galbraith, approving closure of Main Street from 8th Street to 3rd Street contingent upon the approval from the Kentucky State Highway Department for Friday, April 17th thru Sunday, April 19th for a Chamber of Commerce Festival. Motion carried by roll call vote of 5-0 with Plummer, Perraut, Brooks, Galbraith and Allen-Edwards voting Aye.

Executive Session

Motion by Galbraith, seconded by Brooks, to go into executive session for deliberations on a potential future acquisition of real property by a public agency because publicity would be likely to affect the value of a specific piece of property to be acquired for public use or sold by a public agency, pursuant to KRS 61.810(1)(b) at 9:21 a.m.

With no action taken during executive session. Motion by Brooks, seconded by Perraut, to exit executive session and resume regular session at 9:36 a.m. Motion carried by roll call vote of 5-0 with Plummer, Perraut, Brooks, Galbraith and Allen-Edwards voting Aye.

Motion by Galbraith, seconded by Perraut, approving a purchase of real property located on and near 17th Street of approximately 2 acres more or less for \$ 173,800 contingent upon a mutually agreed contractual agreement between the City of Paris and Micah Carrel. Motion carried by roll call vote of 5-0 with Plummer, Perraut, Brooks, Galbraith and Allen-Edwards voting Aye.
