#### CITY OF PARIS ORDINANCE 2022-6

AN ORDINANCE ENACTING AND ADOPTING A SUPPLEMENT TO THE CODE OF ORDINANCES OF THE CITY OF PARIS, KENTUCKY.

WHEREAS, American Legal Publishing Corporation of Cincinnati, Ohio has completed the 2022 supplement to the Code of Ordinances of the City of Paris, Kentucky, which supplement contains all ordinances of a general nature enacted since the prior supplement to the Code of Ordinances of the City; and

WHEREAS, American Legal Publishing Corporation has recommended the revision or addition of certain sections of the Code of Ordinances which are based on or make references to sections of the Kentucky Revised Statutes;

WHEREAS, it is the intent of the Commission to accept these updated sections in accordance with the adopted Ordinances of the City or changes of the law of the Commonwealth of Kentucky;

NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY THE BOARD OF COMMISSIONERS OF THE CITY OF PARIS AS FOLLOWS:

The 2022 S-16 supplement to the Code of Ordinances of the City of Paris, Kentucky, as submitted by American Legal Publishing Corporation of Cincinnati, and attached to this Ordinance is adopted by reference as if set out in its entirety.

Motion by Brooks, seconded by Plummer, awarding Hinkle Contracting the street paving bid for an amount up to \$214,332.00 and authorizing the mayor to sign and execute the contract once the terms are agreed to by the city attorney and staff. Motion carried by roll call vote of 5-0 with Plummer, Brooks, Roberts, Galbraith, and Gibson, voting Aye.

Motion by Gibson, seconded by Roberts, approving the purchase of a K-9 for the police department, and accepting funds received from community partners for the purchase of the K-9. Motion carried by roll call vote of 5-0 with Plummer, Brooks, Roberts, Galbraith, and Gibson, voting Aye.

Motion by Brooks, seconded by Roberts, approving the publishing of an RFP for accident reconstruction crime scene equipment. Motion carried by roll call vote of 5-0 with Plummer, Brooks, Roberts, Galbraith, and Gibson, voting Aye.

Motion by Galbraith, seconded by Gibson, approving June financials as presented by Brad Oberlander, reflecting General Fund Revenues of \$ 12,187,309.00 with expenditures of \$ 9,783,588.00 Utility Fund Revenues of \$ 13,701,394.00 with expenditures of \$ 13,721,313.00.
