

The Paris City Commission met in regular session at 9:00 a.m. viewable on Facebook live at [www.facebook.com/cityofparisky](https://www.facebook.com/cityofparisky) on Tuesday, October 11, 2022.

Mayor Plummer called the meeting to order, and the Pledge of Allegiance was recited.

City Clerk Stephanie Settles conducted roll call.

Upon determining a quorum was present for the transaction of business, City Manager Jamie Miller proceeded to conduct the meeting.

#### **Approval of Minutes**

Motion by Gibson, seconded by Roberts, the motion unanimously carried to approve the meeting minutes of September 27, 2022, regular meeting.

Cathy Kendall addressed the commission with investigation concerns related to the death of her daughter. No action was taken.

#### **Ordinances/Municipal Order**

First reading of ordinance 2022-15 was read relating to local limits and the city's wastewater discharge system.

First reading of ordinance 2022-16 was read regarding the administration of the monthly water meter fee in the city.

Motion by Gibson, second by Galbraith, the motion unanimously carried approving municipal order 2022-17 approving the submittal of projects for the Kentucky cleaner water program funding.

#### **Consent Agenda**

Motion by Galbraith, second by Brooks, the motion unanimously carried approving the Chamber of Commerce request for street closure on Sunday, November 6, 2022, on Main Street between 4<sup>th</sup> Street and Bank Row starting at noon for the Dia de los Muertos festival.

Motion by Galbraith, second by Brooks, the motion unanimously carried approving the publishing of an RFP for access control to doors, interview rooms equipped with video and microphone system, and video surveillance cameras for the police department.

Motion by Galbraith, second by Brooks, the motion unanimously carried approving payment of invoices reflecting claims of \$ 171,392.11 for General Fund and \$ 156,126.79 for Utility Fund.
